Terms and Conditions

It is understood that the Hidden Valley Lake Association Board of Directors may amend from time-to-time rules and regulations concerning the use of the golf course, the conduct of players and reasonable limitations required for play on the golf course during specific periods of time. Golf members shall abide by all such rules and regulations as established by the Board.

Golf Membership fees, for returning members, are due on the first day of July and considered late if not received by July 15, a late fee will be added. Golf Memberships are non-transferable and membership dues are considered non-refundable in the event of early termination, excepting for those special circumstances specifically outlined in the golf course policy.

Hidden Valley Lake Association shall not be responsible for any property of members, dependents of members, or guests of members left at the golf course or at any facilities located on the golf course.

In the event that play on the golf course is restricted by reason of a tournament scheduled for the course, notice shall be posted on the bulletin board at the Pro Shop no later than seven (7) days prior to the time scheduled for such tournament.

It is understood that play at the golf course is not limited to golf course members. The Association shall endeavor to give starting time preference to those with memberships to the extent possible in the orderly operation of its golf course.

The Association reserves the right to terminate all memberships at the HVLA golf course in the event that the Association, without fault on its part, is unable to operate the course by reason of strikes, riots, wars, acts of nature, by condemnation, threat of condemnation, or other causes beyond its control.

All written notices required to be given to a member may be given either by delivering such notice personally to the member or by placing such notice in the United States mail, postage prepaid, addressed to the member at the mailing address shown on the member’s application form.

The members named on this application hereby release Hidden Valley Lake Association and its officers, members, agents, and employees from any and all claims or causes of action (present, past, or future) arising out of any injury, loss, death, or property damage sustained by named Members on the premises of the Hidden Valley Lake Golf Course, its Pro shop, and Restaurant. Furthermore, named Members agree to defend and indemnify Hidden Valley Lake Association, its officers, members, agents, and employees from any claims or causes of action brought against the Golf Course or Association due to Member’s negligence or acts by any guest or family member of the named Members.
